Sub: Repetitive Non compliance of RTM Norms by CBWTFs - reg.

Ref.: This office letter No. 80/HOPCB/ERC, dated 18.05.2023 and E.mails sent time to time.

Your attention is drawn to the above referred letter vide which the status of CBWTFs performance for last one year was brought to your notice. While re-visiting the status of CBWTFs it is noticed that the compliance rate is still displeasing. The % of data capture rate (DCR) is very low as against the required rate of >85%, with only two CBWTFs falling in the compliance zone. Non achieving the required temperature in primary and secondary chambers of incinerators also needs an early attention as it defeats the basic objective of BMW disposal in a proper way. A current status in this regard is attached herewith for ready reference.

Non submission of key information by the CBWTFs, despite reminders, is a cause of concern. Your personal intervention is requested to ensure that the information from all the CBWTFs regarding waste disposal is made available to the Environment Surveillance Centre (ESC) on weekly basis in the enclosed format for proper analysis of RTM data. This would consequently help in achieving the objective of BMW management in more effective way.

An early follow up action from your end is thankfully anticipated.
