Sub : Mandatory Provision for Calibration Facility at Each Industry - reg.

As you are aware that the Govt. of India has developed a self-regulatory mechanism for industries. As part of self-monitoring of compliance the industries have installed real-time monitoring systems, including online continuous emission monitoring systems (OCEMS), at their establishments and have provided credentials to the MPPCB to access the real-time data.


In this context, it is reiterated that for proper operation of OCEMS regular calibration is an important activity for reliability of data and to check possible tampering by some industrial units. It is a matter of pleasure that the MPPCB has already taken up activity over a year back, which is duly acknowledged by the CPCB in earlier instances, but there is need to further strengthen it.

In view of above you are directed to ensure that all such industries falling under 17 categories and Grossly Polluting Industries under your jurisdiction comply as follows:

1. Calibration facility is available at the industry end.
2. Instruments are periodically calibrated & calibration data is also entered automatically into the system through the software installed at industry end.
3. Remote calibration facility is available at each gaseous OCEMS.

Please ensure the compliance of above by all the industries positively done by 31.05.2018.


